

DECLARATION UPON ENTERING RUNNING ACES DURING COVID-19 PANDEMIC

Due to the Covid-19 (Coronavirus) pandemic Running Aces has implemented initiatives to minimize the risk of exposure by restricting attendance in the stable area:

The following measures are in place at the venue:

- Only those people who are directly involved with the care and training of animals and who display a current MRC license; MRC personnel; and Running Aces staff, will be permitted entry to the stable gate
- Other people including owners will be refused entry
- Social distancing – avoid shaking hand, stay six feet away from others
- Good hygiene practices, regularly wash and sanitize your hands
- Wear a mask when working in close proximity to others
- Monitor your health and report concerns
